These smaller boats require proof of \$100,000 boat Liability Insurance. A duplicate set of cabin and ignition keys are to be kept in our locked key cabinet in case of an emergency. The first month's rent and a deposit equal to one month's rent are to accompany this application. The Bal Harbour Marina & Canal Rules and the Boat Slip License Agreement will be signed and reviewed routinely. All signed paperwork and fees, along with a current insurance certificate, must be received by the management office before your boat enters the Bal Harbour Marina.

I agree to abide by the Bal Harbour Marina and Canal Rules and the Boat Slip License Agreement. I also agree to give thirty (30) days written notice before vacating the slip or my deposit may be forfeited.
